WHEN: 2:30 Wednesday October 20 through 5pm Saturday October 23 (Dr. Snipes and the staff will be around Sunday morning to answer any lingering questions, but there are no scheduled activities.)

WHERE: Cumberland Mountain State Park Crossville, TN

COST: \$350 includes all sessions, light refreshments throughout the day and a catered lunch each full day. Cancellations must be made by September 10 to receive a refund less a \$5 processing fee. Lodging, breakfast and dinner are **not** included in the registration fee.

LODGING: Cabins are [available for rent**](#) at the park (some are even animal friendly), or you can choose from any of the local hotels or AirBnBs. (The rustic cabins do have wifi, kitchens and cable but are *very* rustic. The deluxe cabins are much more akin to a hotel experience. Many of the cabins have two bedrooms so you can bring a friend and split the cost 😊)
